

COOKIES POLICY

1. What the Cookies Policy is about

With this Policy our Company " KAINOTOMES LYSEIS KAI YPIRESIES MONOPROSOPI ETAIREIA PERIORISMENIS EUTHYNIS" and the trade name «INSS SINGLE MEMBER LTD», provides the users of its website <https://inss.com.gr/> further information about the use of Cookies. In particular, we inform you about the meaning of Cookies, the type of Cookies we install, the type of data that they collect, the purpose, the period, the providers and the specific way to set or disable Cookies.

2. What are the Cookies

Cookies are small information files (txt files), which are installed through the browser of the user / visitor of the website, on the computer or on his mobile device (in the application files of the browser and / or in the archive file structure of each user of the terminal device), when visiting the website.

Cookies are used to make our website more functional and popular with you. Cookies allow us to improve your online experience and the services provided to you. We thus install, depending on each purpose, "first-party Cookies", which means Cookies installed by us, and "third-party Cookies", installed by others (e.g., website implementation platform) through our website.

Every time you visit the website, you will be asked to accept or reject specific categories of Cookies. If you choose to continue browsing our website, you agree at least to the use of Cookies which are necessary for the functionality of the website and which cannot be disabled.

3. What kind of cookies do we use

At this website, we currently use only the absolutely necessary Cookies. These Cookies are absolutely necessary for the operation of our website, so that you can browse the website and use its functions, such as access to secure areas. Without them, the services provided to you through the website cannot be provided.

Other cookie categories concern preferences, statistics and marketing-advertising. In the event that we use such categories of cookies, you will be informed through the banner when you enter the website, and also through the amended Cookies Policy, which you will always find updated on our website.

In the table below, you can have more detailed information about the Cookies we use, by category and provider, and receive information about them.

4. How to the adjust the use of Cookies

When entering the website, you are getting informed about the use of Cookies by us and you are asked to select the categories of Cookies that you wish to accept or disable. With the above selection, you explicitly provide your consent for the use of specific categories of Cookies, kept in a relevant electronic file of your choices by us.

The absolutely necessary for the operation of our website Cookies cannot be opted-out and your consent is not obtained for them. In every connection from another device or browser, a new setting will be made.

In any case, it is at your discretion to control the use of Cookies, to oppose their use and to revoke whenever you wish, your consent, through the above procedure, but also after your initial selection, through the icon "Settings" at the bottom of the website, where you will be able to modify and save any changes.

We currently use only necessary cookies when you browse our website.
